The inspiration for this year's Impact Report comes from the journey we began in 1983 serving Cincinnati's most vulnerable families – those without a home. Throughout these 37 years Bethany House has always been focused on the future – but never more so than in 2019.

For our families, the future was stable housing, long term-self-sufficiency, and medical and mental healthcare.

For our parents, it was ensuring they had a job and the necessary life skills to keep their children in stable housing.

For our children, it was getting them enrolled in school, introducing them to goal-setting, and teaching resilience. For too many, it was connecting them with medical and mental care health services.

For our staff, it was learning, growing, evolving and adapting to accommodate the special needs of our families in a changing world.

For the agency, it was collaborating with strategic partners, forging relationships with changemakers in housing, education, health care, transportation, and child care to create the most impact for children and their parents.

Throughout the year, Board members, committee members and staff focused on the future like never before. They worked to make their vision of a new Bethany House consolidated shelter and comprehensive services center a reality. The property in Bond Hill purchased in 2018 will be transformed into a trauma-informed and family focused facility, providing more education, security and healing for all who enter.

After working with fundraising consultants over the summer, the board approved the start of a Capital Campaign. In November, our fundraising kicked off with the biggest gift Bethany House has ever received – \$1.25 million from Amazon founder Jeff Bezos' Day 1 Families Fund. By the end of 2019, we had raised over \$4 million toward our goal of \$16.5 million.

You will read in this report that 2019 was our most impactful year yet, ensuring 606 families found safety in shelter, established a new home and developed a path to independence. **This was only possible because of your financial support, volunteer hours, in-kind donations and the work of our dedicated team of staff, volunteers and board members.**

Bethany House is on a mission to stop the cycle of family homelessness in our community. We pray you will continue to help us fulfill this vital mission.

Please celebrate with us as we review the IMPACT you had in 2019!

All of our families in the Fairmount and Bond Hill congregate shelters were moved to hotel rooms, most staff worked from home, and volunteer activities were temporarily suspended. THE HIGHLIGHTS

SHELTER

In 2019 Bethany House sheltered more children than ever before in our 37-year history – **797 children**

94% of shelter families moved to positive housing

29% exited shelter with increased income

2-year recidivism rate (return to shelter) was **4.8% in 2019**

HOUSING

In 2019 Bethany House housed **10% more families** than 2018

43% increased or maintained their total income.

2-year recidivism rate (return to homelessness) for Rapid Re-Housing was **10%**.

Shelter Diversion prevented **89% of families** from entering shelter within 12 months after leaving the Shelter Diversion program.

In 2019 Bethany House more than **doubled** their homelessness prevention services.

281 families received case management, financial and/or in-kind support after leaving shelter or a housing program, reducing the risk of repeat homelessness

2019 Awards

Bethany House was honored to receive the **2019 DUKE ENERGY POWER OF COMMUNITY AWARD** and \$500. The social workers, case managers and leadership of BHS were recognized for their excellent work and for their support of Duke’s community outreach efforts since the inception of the Duke Energy Community Service Workshop 23 years ago.

Over the years we evolved to accommodate the myriad of additional challenges confronting homeless families through collaboration. **Today, Bethany House collaborates with more than 80 organizations to meet the complex needs of families experiencing homelessness.** Partnering improves access to comprehensive, coordinated care, maximizes existing resources and empowers families on the long road to self-sufficiency.

The Sisters of Charity received the Bethany Beacon Award for their leadership in founding Bethany House, their commitment to building a more just society, their dedication to the poor and underserved in our community, and for their continued support of Bethany House.




